## 2. Purposes, legitimation and conservation of the treatments of the data sent through:

#### • RESERVATION FORM.

*Legitimation:* The user's consent when making the reservation through our form and by checking the acceptance box for sending information.

Conservation: Until the end of your stay and later during the legally established periods. If you have accepted commercial shipments, until you request your withdrawal.

#### • EMAILING.

*Purpose*: Answer your requests for information, attend to your requests and answer your queries or doubts.

*Legitimation*: The user's consent when requesting information through the email address.

Conservation: Up to once your request is answered by email, if it has not generated a new treatment.

Obligation to provide us with your personal data and consequences of not doing so.

The provision of personal data requires a minimum age of 14 years, or where appropriate, have sufficient legal capacity to contract.
